In the interest of administration, the following transfers / postings of Forest Officers (Heads of Departments) are hereby ordered with immediate effect :-

The above arrangement shall be purely on temporary basis and shall not confer any preferential right to the officer / s to claim any benefit.

The above arrangement shall also be subject to any case pending in any court of competent jurisdiction. This shall be further subject to any case / enquiry pending against the officer/s before the department or investigating agency. The department shall reserve the right to revert back / repatriate any of the officer to his position as occurring as on date.

The officer/s shall be deemed to have been relieved with immediate effect.


