In pursuance of Rule 3 of J&K Daily Rated Workers/Work Charged Employees (Regularization) Rules, 1994, sanction is accorded to the creation of 03 (Three) temporary posts of Helpers in the pay scale of Rs. 2550-3200 (pre-revised) in the Forest Department (Territorial) for regularization of services of following, Daily Rated Workers with effect from 01-04-2001, subject to the condition that the posts shall cease to exist as and when the Class-IV substantive vacancies in the said pay scale become available:-

This order is further subject to all the terms and conditions set by Finance Department from time to time in similar cases and also subject to further verification by Pr. Chief Conservator of Forests regarding authenticity of master rolls, initial engagement orders, qualification, age proof and other guidelines as laid down in the Jammu & Kashmir Daily Rated Workers / Work Charged Employees (Regulation) Rules, 1994.

The formal orders of regularization shall be issued by the Pr. Chief Conservator of Forests, J&K, Srinagar after fulfilling the requisite conditions as laid down in SRO-64 of 1994 dated 24.3.1994 and verification of Character and antecedents, certificates etc. In addition the relaxation of age/qualification bar, if any, found required at the time of initial engagement of these Helpers shall be worked out and submitted to the Administrative Department (Forests) for consideration in terms of Rule 4(c) of SRO-64 /1994.

This issues with the approval of Empowered Committee constituted vide Government Order No.139-F of 2015 dated 19.08.2015 in its 10th meeting held on 09.03.2017.
