As recommended by the J&K Public Service Commission, sanction is hereby accorded to the appointment of Shri Arshad Ahmad Lala S/o Gh. Qadir Lala R/o Khawaja Sahab Baramulla (Category OM), as Range Officer Grade - I in the pay band of Rs. 9300 - 34800 with Grade Pay of Rs. 4280/- in the Forest Department.

The appointee shall report to Principal Chief Conservator of Forests within 21 days from the date of issue of this order. He shall be allowed to join only on production/scrutiny of the following certificates in original: -

- 1) Academic /Technical Qualification Certificate
- 2) Permanent Resident Certificate
- 3) Health Certificate issued by the Chief Medical Officer.
- 4) Certificate from the General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under self employment schemes has been taken.
- 5) Any other certificate required under rules.

The appointment shall be subject to the following conditions: -

- a) He shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by Head of the Department concerned, the candidate shall have

no right to claim his appointment as Range Officer and his appointment shall be deemed to have been cancelled ab-initio.

b) Verification of the qualification certificates.

The appointee will be on probation for a period of two years. His appointment shall be governed by the provisions of SRO 400 of 2009 dated 24.12.2009 issued by the Finance Department.


