Sub: Transfer and posting of Forest Officers.

Government Order No: 277 - FST of 2012
Dated: 28 .06.2012.

In the interest of administration, the following transfers and postings of the Forest Officers are hereby ordered with immediate effect: -

1. Shri Imtiaz Ahmad, Assistant Wildlife Warden, Central, is transferred and posted as Assistant Wildlife Warden South Kashmir vice Shri Mohd Sidiq Mir.
2. Shri Bashir Ahmad Wani, I/c ACF, presently attached with CCF Kashmir, is transferred and posted as I/c DFO Social Forestry, Anantnag against an available vacancy.
3. S. Surjeet Singh, I/c ACF, Divisional Manager, SFC, Rajouri is transferred and posted as I/c Assistant Wildlife Warden, Rajouri against an available vacancy.
4. Shri Rafi Ahmad Bhat, Range Officer-I, Principal Forest Guard's Training School, Doomi, Akhnoor, is transferred and posted I/c DFO Nowshera against an available vacancy. Shri T. B. Singh, DFO Urban Forestry, Jammu, shall hold the charge of the post of Principal, Forest Guard's Training School, Doomi, in addition to his own duties till further orders.
5. Shri Mohd Sidiq Mir, I/c Assistant Wildlife Warden, South Kashmir, is transferred and posted as I/c Wildlife Warden, Central, vice Shri Imtiaz Ahmad.
6. Shri G. M. Bhader, I/c DFO, SC & FC Division, Pohru, is transferred and directed to report to PCCF. The charge of the post of DFO SC & FC Division Pohru shall be held by Sh Hakim Mukhtiar Ahmad, I/c RO-I, DSCO Kupwara.

It is further ordered that Shri Mushtaq Ahmad Chowdary, (Range Officer-I), I/c DFO Batote shall hold the charge of the post of Project Officer, National Highway Project, Batote, in addition to his own duties, till further orders.

The placement of the officers except S. No: 1, against higher posts in their own pay and grade is purely a temporary arrangement and will not confer any right on them to hold the higher posts on substantive basis which shall be filled-up strictly in accordance with the prescribed rules. They shall have no claim over these posts and shall be reverted to their substantive positions as and when required, without any notice.

The above transfers / postings shall also be without prejudice to the outcome of court cases, if any, pending before any competent Court.


