As recommended by the Empowered Committee constituted vide Government Order No. 1423-GAD of 2009 dated 14.10.2009 and in terms of the provisions of the Jammu and Kashmir Civil Services (Special Provisions) Act, 2010, sanction is hereby accorded to the regularization of adhoc service of Shri Adil Rashid Shan (DDR Forester) S/o Abdul Rashid Shan R/o Doda in the PB-1 Rs. 5200-20200 plus GP Rs. 2800/- in relaxation of upper age bar by 10 months as on 01.01.2013.

The appointment of the above adhoc employee shall be governed by the provisions of SRO-400 of 2009 dated 24.12.2009 issued by the Finance Department and the Head of the Department/concerned Drawing & Disbursing Officer will ensure that the allowances other than what was admissible/due, if any, earlier drawn shall be recovered from the appointee strictly in accordance with the relevant rules.

The appointee shall be on probation for a period of two years. The Department where the appointee is presently posted shall allow him to formally join on the post of DDR Forester, only after checking the following certificates in original:-

- 1) Date of Birth Certificate.
- 2) Permanent Residence Certificate (PRC).
- 3) Academic Qualification Certificates.
