In pursuance of Rule 3 of J&K Daily Rated Workers/Work Charged Employees (Regularization) Rules, 1994, sanction is hereby accorded to the creation of 09 (Nine) temporary post of Helpers in the pay scale of Rs. 2550-3200 (pre-revised) for regularization of equal number of Daily Rated Workers of (Shopian Forest Division), Forest Department (Territorial) whose names are given in annexure-"A" to this Government Order with effect from the dates shown against each subject to the fulfilment of following terms and conditions:-

1. The regularization orders of Daily Rated Workers shall be issued by the Principal Chief Conservator of Forests J&K, subject to the fulfilment of following terms and conditions :-
 - (a) That he is a Permanent Resident of the State of Jammu and Kashmir.
 - (b) That on the date of his initial appointment, his age was within the minimum and maximum age limit as prescribed for appointment in Government Services;
 - (c) That he is not retiree from any State or Central Government service or any Local Body, Public Sector Undertaking or Autonomous Body in or outside the State;
 - (d) That his work and conduct has remained satisfactory during the period he worked as Daily Rated Worker and no disciplinary proceedings are pending against him.
 - (e) That he has continuously worked in the Department from prior to 31-01-1994 till date and fully qualify as per SRO-64 of 1994;
 - (f) That no enquiry i.e. departmental or in Vigilance Organization/Crime Branch/Police Station is pending against these incumbents and no antecedents from the concerned agencies;
 - (g) That the incumbents fulfil all the terms and conditions as laid down in SRO 64 of 1994 and record note of meeting of Empowerment Committee held on 09-03-2017 endorsed vide O.M No.A/54(2015)-139 dated 19-04-2017.
2. The PCCF shall ensure that eligibility criteria for regularization as per SRO-64 of 1994 is strictly established and complete original record and bio-data is verified in respect of each DRW and in case any of the DRW fails to fulfil the required terms and conditions, the HOD shall convey the same to Administrative Department. If any DRW regularized by the HOD, at a later

- stage found with any of the deficiency, the whole responsibility shall lie upon the HoD concerned and further legal action under law/rules will be initiated against the said officer.
3. Number of posts so created shall not be utilized except for the purposes for which these have been created.
 4. The posts so created shall get reduced as and when the existing incumbents vacate the posts by way of termination/retirement/death. The Budget provisions under the wages component shall be correspondingly reduced in the current year's Budget of concerned Divisions.
 5. The utilization certificate of the posts approved shall be made available to the Administrative Department within one month from the date of issue of this order.
 6. The cases involving relaxation in age/qualification bar should be established by the PCCF,J&K and refer to the Administrative department for further necessary action.
 7. Arrears from date of regularization to the date of issue of regularization order shall be paid in five equal annual instalments after projecting the same under Annual Budget Estimates of the Department.

Sanction is also hereby accorded to the condonation of gutted periods of DRWs mentioned against each as per annexure "A" to this Government Order, as conveyed by the General Administration vide O.M No: GDC- 190/CM/2017 dated 25-10-2017.
