Whereas vide letter No: PSC/Exam/RoF/2004 dated 22.07.2011 issued by the Jammu and Kashmir Public Service Commission, Srinagar, Shri Mudasir Mehmood Malik was selected for the post of Range Officer Grade-I; and

Whereas, vide Government Order No. 301-FST of 2011 dated 04.08.2011, the aforementioned selectee was appointed as Range Officer Grade-I with his name figuring at S.No. 8 of the aforesaid Government order; and

Whereas, through local dailies, all the appointees were asked to report to the Pr. Chief Conservator of Forests, J&K for further duties; and

Whereas, Pr. Chief Conservator of Forests, J&K vide his letter No:PCCF/Estt/G.RO/2676 dated 17.08.2011 reported that one of the selectee namely Shri Mudasir Mehmood Malik had not joined his duties till 17.08.2011; and;

Whereas, through Notice dated 19.09.2011, published in Daily News Papers of Srinagar/Jammu and a copy thereof also dispatched on the Home address of Shri Mudasir Mehmood Malik, Shri Mudasir was finally directed to report to the Pr. Chief Conservator of Forests, J&K within 10 days positively i.e. by or before 29.09.2011, cautioning him that his failure to report for duty by or before 29.09.2011 will lead to cancellation of his appointment to the said post; and;

Whereas, despite final notice through local dailies, the appointee Shri Mudasir Mehmood Malik failed to report for duty by or before 29.09.2011; and;

Whereas, Shri Mudasir Mehmood Malik has already been appointed as Assisatn Conservator of Forests vide Government Order No: 233-FST of 2011 dated 18.045.2011 and is now presently undergoing SFS training course at Central Academy for State Forest Service (CASFOS) Dehradun.

Now, in the above backdrop, the appointment of Shri Mudasir Mehmood Malik S/o Farooq Ahmad Malik R/o Forest Research Institute Univ. Shisham Hostel Room No: 18 MSC Wood as Range Officer Grade-I in the Forest Department vide Government Order No: 301-FST of 2011 dated 04.08.2011 is hereby **“CANCELLED”** with immediate effect.
