Subject: Show cause notice for non-submission of property returns.

Whereas, it is mandatory to submit property returns annually on the last day of January every year to the General Administration Department (Vigilance) by all Gazetted officers including IFS officers;

Whereas, most of the officers have submitted their returns either directly to the General Administration Department (Vig.) with a copy to the Administrative department (F&EE) and some officers have forwarded their returns only to the Administrative Department(F&EE) which also stands referred to the GAD(Vig.) ;

Whereas, a number of communications in the form of Circulars and the Office Memorandums have been issued to Heads of the Departments to impress them to ensure timely submission of Annual Property Returns by their subordinate staff;

Whereas, a number of officers/ officials of the Forest, Environment & Ecology Department in the Field, as per the list enclosed, , have failed to submit their returns despite extension of time for filing the APRs ; and

Now therefore, this show cause notice is issued with the direction to the defaulters that why action as warranted under rules shall not be initiated against them. They are also directed to explain their position within 02 days positively failing which it will be presumed that they have nothing to say in their defence for this kind of dereliction of duty.


