
**The Sanction is subject to the fulfilment of following conditions:**

3. The Deptt/ Executing agency shall utilize the funds only after obtaining the Administrative Approval/ Technical Sanction from the competent authority.
4. The Deptt/ Executing agency shall ensure that there is no overlapping/ duplication in adoption of schemes/ incurring of expenditure from any other scheme of the State or Central Govt.
5. No compromise on the quality and quantity of the work shall be allowed.
6. Physical and financial progress report of the work shall be submitted to the Administrative Deptt (Forest).
7. FA/CAO/AO of the concerned Deptt shall vouchsafe the utilization of funds as per the codal/ procedural guidelines issued by Govt. of India.
8. The CED, WUCMA shall submit utilization certificate of the funds utilized by or before 31-03-2018 to Administrative Department.
