Subject: Creation of one temporary posts of Helpers in the Forest Department (Territorial).

Government Order No. 34 -FST of 2018

In pursuance of Rule 3 of J&K Daily Rated Workers/Work Charged Employees (Regularization) Rules, 1994, sanction is accorded to the creation of 01 (One) temporary post of Helper in the pay scale of Rs. 2550-3200 (pre-revised) for regularization of Shri Gh. Rubani S/o Lalbaz R/O Shundi, Daily Rated Worker of SC& FC Forest Division Phoru Langate, Forest Department (Territorial) with effect from 01-04-1999, subject to the fulfilment of following terms and conditions:-

1. The regularization order of Daily Rated Worker shall be issued by the Principal Chief Conservator of Forests J&K, subject to the fulfilment of following terms and conditions :-
 - (a) That he is a Permanent Resident of the State of Jammu and Kashmir.
 - (b) That on the date of his initial appointment, his age was within the minimum and maximum age limit as prescribed for appointment in Government Services;
 - (c) That he is not retiree from any State or Central Government service or any Local Body, Public Sector Undertaking or Autonomous Body in or outside the State;
 - (d) That his work and conduct has remained satisfactory during the period he worked as Daily Rated Worker and no disciplinary proceeding is pending against him.
 - (e) That he has continuously worked in the Department prior to 31-01-1994 till date and fully qualifies as per SRO-64 of 1994;
 - (f) That no enquiry/investigation i.e departmental or in Vigilance Organization/Crime Branch/Police Station is pending against these incumbent and character/ antecedents report is received from the concerned agencies;
 - (g) That the incumbent fulfills all the terms and conditions as laid down in SRO 64 of 1994 and record note of 6th meeting of Empowerment Committee held on 31-03-2016 endorsed vide O.M No.A/54(2015)-47 dated 12-05-2016.
2. The PCCF shall ensure that eligibility criteria for regularization as per SRO-64 of 1994 is strictly established and complete original record and bio-data is verified in respect of DRW and in case the DRW fails to fulfil the required terms and conditions, the HOD shall convey the same to Administrative Department. If the DRW is regularized by the HOD, at

later stage and found with any of the deficiency, the whole responsibility shall lie upon the HoD concerned and further legal action under law/rules will be initiated against the said officer.

3. The post so created shall not be utilized except for the purposes for which has been created.
4. The post so created shall get reduced as and when the existing incumbent vacate the post by way of termination/retirement/death. The Budget provisions under the wages component shall be correspondingly reduced in the current year's Budget of concerned Divisions.
5. The utilization certificate of the post approved shall be made available to the Administrative Department within one month from the date of issue of this order.
6. The relaxation in age/qualification bar, if any, should be established by the PCCF, J&K and refer to the Administrative department for further necessary action.
7. Arrears from date of regularization to the date of issue of regularization order shall be paid in five equal annual instalments after projecting the same under Annual Budget Estimates of the Department.
