- ii. Academic/Technical Qualification Certificate.
- iii. Health Certificate issued by an officer not below the rank of Chief Medical Officer.
- iv. Domicile Certificate.
- v. Relevant Category certificate (in case of candidates belonging to reserved categories).
- vi. Certificate from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
- vii. Any other certificate required under rules.



The candidate(s) who fail to join within a period of 21 (twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.

Salary of these appointees shall not be drawn and disbursed to them unless satisfactory report in respect of Qualification Certificate / Reserved Category Certificate is received.

The appointment of the above candidate(s) shall be governed by the "New Pension Scheme" as per SRO -400 of 2009 dated 24.12.2009.

The appointees shall be on probation for a period of two years. If, on verification, the certificates produced by the appointee proved to be fake or forged, the appointment shall stand as cancelled ab-initio.
