- vi. Certificate from the concerned District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self employment scheme has been taken by the appointee.
- vii. Any other certificate required under rules.

The candidate(s) who fail to join within a period of 21 (twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.

Salary of these appointees shall not be drawn and disbursed to them unless satisfactory report in respect of Qualification Certificate / Reserved Category Certificate is received.
