In exercise of the powers conferred by sub-section (3) of section 7 of the Jammu and Kashmir Non-Biodegradable Material (Management, Handling and Disposal) Act, 2007 and in supersession of Notification SRO 45 dated 3rd of February, 2017, the Government after consultation with Prescribed Authority (Jammu and Kashmir Pollution Control Committee) hereby imposes ban on the manufacturing, stocking, distribution, sale and use of polythene carry bags, plastic sheets or like, cover made of plastic sheets, packaging sheets and multilayer packaging less than 75 microns in thickness within territorial limits of Jammu and Kashmir w.e.f 30th September, 2021 and 120 microns in thickness w.e.f 31st December, 2022, and Non-woven Plastic carry bags of less than 60 gm per square meter (GSM) w.e.f 30th September, 2021.
